Training:	Training in this spec is required by, QA and Materials Group personnel that purchase raw material or review Material Purchase Orders.

Quality Management System	All suppliers are required to have an implemented quality management system in accordance with accepted international standards.		
Right of Access	1. For purposes of inspection and expediting of the services covered by Patriot Forge Co. PO's or work thereon, Patriot Forge Co. reserves the right of access by Patriot Forge Co. personnel, their customer, and regulatory authorities to the applicable areas of all supplier facilities, at any level of the customer's supply chain, involved in the work indicated on the Patriot Forge Co. PO and to all applicable records. This includes access to Patriot Forge Co.'s supplier's subcontractor's premises.		
	 Any approval by such representative shall not relieve the Supplier from the obligation to comply with the requirements of the Patriot Forge Co. PO and this document (PF059-S) in every respect. 		
Purchase Orders	The Patriot Forge Purchase Order communicated to the supplier will outline the applicable processes, products, and services to be provided including any relevant technical data.

Approval	If approval of products, services, methods, processes, equipment, or the release of product is required it will be outlined on the Patriot Forge purchase order.			
	No subcontracting of operations directly related to Patriot Forge Co. PO's is allowed except with Patriot Forge Co. prior written approval.			
Subcontracting	2. Where subcontracting is permitted by Patriot Forge Co., the supplier shall pass on all of the Patriot Forge Co. PO requirements to their supplier.			
Subcontracting	3. For each Patriot Forge Co. approved subcontracted requirement performed by supplier, a Certificate of Compliance will be required (see section 7 items 1-6).			
	4. Supplier retains responsibility for meeting quality requirements on any subcontracted operations or services.			
	All employees involved in processing Patriot Forge orders shall be determined to be competent by the supplier. Any qualification requirements will be specified by Patriot Forge on the purchase order.

Communication	All suppliers are to communicate with Patriot Forge using e-mail, telephone, fax, or letter as appropriate to the situation.			
Control and Monitoring	Patriot Forge analyzes supplier performance based on scrap percentage and on-time delivery. The supplier will be notified if results indicate action required on their part. Thresholds are defined annually by Patriot Forge.			
Source Inspection	Any required inspections on the supplier's premises by Patriot Forge or its customers will be indicated on the Patriot Forge purchase order.			
Statistical Techniques	Product acceptance shall not be based on statistical techniques.			
Counterfeit Parts	Suppliers shall have adequate controls to prevent the use of counterfeit items.			
Certification from Melting Mill	 The Original Mill Certification (OMC) package from melt source suppliers shall contain: Certified chemistry and statement of compliance status with respect to specifications or conditions imposed Scope of operations performed, i.e., melting and other in-house operations performed, including address at which they were performed Mercury free statement No weld repair statement Statement of formal Quality Program (rev/date) in effect during processing of material. The verbatim statement – "The recording of false, fictitious or fraudulent statements or entries on this document may be punishable as a felony under Federal Statutes" For each Patriot-approved subcontracted operation performed by Supplier - a Certificate of Compliance which contains items 2. – 6. above. Note: Patriot Forge Co. will provide an approved Certificate of Compliance template if the supplier does not have their own. Please request it from the Patriot Forge Co. Quality department if required.

Product Conformance,	1. The supplier guarantees that all goods and services covered by the Patriot Forge Co. PO shall conform to the specifications, drawings, samples or other description described therein; shall be fit and sufficient for the purpose intended, merchantable, of good material and workmanship and free from defect, and that goods and services of supplier's design will be free from defect in design.		
Warranty and Disclosure of Non- Conformances	2. Known or suspected nonconformance with the requirements of the Patriot Forge Co. PO shall be brought to the attention the Patriot Forge Co. Quality department for review and written acceptance <i>prior to shipment</i> . Known or suspected nonconformance with requirements <i>detected after shipment</i> shall be brought to Patriot Forge Co.'s Quality department's attention in writing as soon as possible, e.g., if linked material or related processes are found to be defective at another customer.

Marking/ Identification	 Part identity shall be maintained throughout all processing. Stamp, tag, or permanently label heat#, grade identification and Patriot Forge Co. PO # on each piece or bundle. Contact Patriot Forge Co. for further clarification if required. Material received with incomplete or illegible markings will be returned to the supplier for correction at the supplier's expense. 		
Ingot Processing	 Any non-conformance with the following guidelines shall be referred to Patriot for written acceptance prior to shipping: No cold cropping (sawing) without prior Patriot approval Conditioning/Grinding/Cropping as detailed on PO Surface condition shall be free of defects or holes greater than 3/8" in diameter or depth. Spout lengths shall not exceed 6". Cropping on hot-cropped ingots shall be uniformly within 20% of square to maximize forging yield. Top and bottom on cropped cylindrical ingots shall be marked as follows: T B B B T B T B B T T B T T B T T B T T T T T T		
Billet Processing	 Any non-conformance with the following guidelines shall be referred to Patriot for written acceptance prior to shipping: Billets shall have saw cut or hot cut / cropped ends. Surface Conditioning/Grinding as detailed on PO Surface condition shall be free of defects. Suitable for direct upset. Tops and to be marked accordingly.

Concast / Bloom Processing	 Any non-conformance with the following guidelines shall be referred to Patriot for written acceptance prior to shipping: Concast / blooms shall have saw cut or hot cut / cropped ends. Surface Conditioning/Grinding as detailed on PO Surface condition shall be free of defects and suitable for direct upset. Where processing allows Tops, bottoms and centers shall be marked accordingly.
Handling/ Processing Restrictions	 Contact with mercury, or any mercury device is prohibited. No welding or weld repair is permitted without Patriot Forge Co.'s prior written approval. Supplier shall be responsible for ensuring that the material is free from radioactive contamination.
Acceptance and Delivery Commitment	 By acknowledging receipt of the Patriot Forge Co. PO (or by shipping the goods or performing the services called for by the PO), the supplier agrees to the terms and conditions of sale contained on the PO. Any additional or different terms or conditions contained in any acknowledgement of the PO by the supplier shall be deemed objected to by Patriot Forge Co. without the need of further notice of objection and shall be of no effect nor in any circumstance binding upon Patriot Forge Co. unless accepted by Patriot Forge Co. in writing. Acceptance or rejection by Patriot Forge Co. of any such additional terms or conditions shall not constitute an acceptance of any additional term or condition on any other PO's. Order must be acknowledged via e-mail to the issuer of the PO, using a duplicate of the supplier's acknowledgement document, giving definite shipment date and confirming prices. Early deliveries (more than 1 week early) shall not be shipped without written authorization by the issuer of the PO. Patriot Forge Co. shall be notified ASAP of any significant risk of, or certain delay in delivery of

Required Documents - All Shipments	 Every part or package of parts and all related paperwork shall be marked with a minimum of: a. Grade Identification, Heat #, Patriot PO# b. Other information as specifically identified on PO. 	
Freight	 All materials must be blocked on 4" x 4" risers on open trailers for overhead crane removal. No Coil Bunks. Seller must pay freight both ways on rejected material. If no applicable pre-existing freight agreement exists with Patriot, contact Patriot Traffic Department and/or Issuer of Purchase Order prior to acceptance of order. Seller accepts responsibility for back charges if material is unable to b unloaded or is rejected due to the above restrictions not being adhered to. 	
Canadian Shipments Originating in the USA	 Goods being shipped by US suppliers to any Canadian division of Patriot Forge Co. MUST HAVE a Commercial Invoice with Country of Manufacture and Currency North American suppliers who have not provided a blanket NAFTA certificate must indicate on packing slip if "goods qualify for NAFTA" and where so, submit a NAFTA certificate with shipment. Shipping instructions to Canada – Canadian shipments to be cleared at Canada Customs by WG McKay Customs Brokers. 	
Conflict Minerals	1. Pursuant to section 1502 of the U.S. Dodd-Frank Wall Street Reform and Consumer Protection Act, All suppliers are required to adhere to the provisions of this document and not engage in the direct purchase of "Conflict Minerals" from the Democratic Republic of Congo (DRC). Failure by the supplier to adhere to this legislation will result in them being removed from our approved vendors list.	
REACH and RoHS	Material Manufactured for Patriot Forge Co. is to comply with REACH and RoHS requirements.	
Mandatory Hold Points	When required by the Patriot Forge Co. purchase order, hold points will be included in the supplier's inspection and test plan in order for Patriot Forge Co. or its customers to verify compliance to contract requirements.
